This year, Intersect Illinois is developing our annual report to reflect the 2022 fiscal year (July 2021 – June 2022) and I'm happy to report that we're generating growth, development and jobs throughout the state. We surpassed FY 2021's job total by 10 percent, resulting in over 1,880 new jobs for the people of Illinois. In addition, we more than doubled our close rate, suggesting a better match between our prospects and Illinois' assets.

As our economy emerges from the pandemic, companies are making location decisions. And, while there is a shift in the types of companies that are growing, one thing remains true – Illinois offers companies from a diverse array of industries the unmatched talent, infrastructure and location that make it an ideal location for business.

Intersect Illinois saw a surge of project opportunities during FY22. On the following pages, you will find a range of companies, from giants like Amazon to small, international companies choosing to grow their businesses in Illinois. In all, Intersect Illinois helped to bring over 1,880 jobs and \$402 million dollars to Illinois this past fiscal year.

Our strategy is simple. We target companies in the industries where Illinois is most attractive. For Illinois that means manufacturing, electric vehicles, tech, agribusiness, life sciences, and logistics. We reach these companies through a national marketing campaign and focused business development activities. While the timeline it takes from initial outreach to completion is quite long, we've seen a tremendous uptick of companies, consultants, media and other partners taking notice of our efforts. We've utilized events such as SelectUSA, community speaking opportunities and FAM tours in order to increase awareness of Illinois' position as a premier global business destination.

Statewide analysis shows that Illinois saw 357 relocations and expansions in FY22, bringing more than 16,000 jobs and \$7B in investment throughout the state. Industries that saw growth include advanced manufacturing, agribusiness and life sciences. These are the similar to the industries we are targeting.

Best of all, we're just getting started. With companies continuing to see the benefit of being in Illinois, the momentum is strong. I encourage you to join us in showcasing to businesses across the country - and the world - why they should be in Illinois.









# 02 | INTERSECT ILLINOIS ASSISTED PROJECTS (FY22)





## Capital Investment





4Front, the vertically integrated cannabis operator and retailer, announced a multiphase expansion project to build an up to 558,000-sq.-ft. cultivation and production facility in Matteson. The project will bring 500 jobs and \$106M to Illinois.



Amazon will construct a distribution center in DeKalb adding hundreds of jobs. Since 2010, Amazon has invested more than \$14B in Illinois, where it employs 43,000; its main investments include 20 fulfillment and sortation center sand 20 delivery stations.



Danobat, a European-headquartered machine tool manufacturer, chose to move its U.S. operations from Texas to Illinois; after operating in the area decades ago, the company chose to come back to Illinois to better access the supply chain and talent. The new 12,700-sq.-ft. headquarters features commercial, production and quality control operations.



Diehl, a large German company, announced plans to expand its operations assembling advanced water meters in Lisle, creating 35 jobs over five years. The company considered other states where Diehl has a presence.



Eeroq, a leader in quantum computing using electrons on helium, chose Illinois because of the state's position as a hub for quantum computing; located within Humboldt Park's The Terminal, the company bought 45 jobs and \$6M in investment.



Formic, a robotics and automation company with existing locations in California and North Carolina, is building its sales and engineering presence in Chicago because of its strong ecosystem. "Intersect Illinois has been a great partner for Formic Technologies as we have looked to grow and expand our presence in Illinois and the Midwest. Formic has appreciated and valued the guidance, insights, feedback and thoughtful suggestions that the Intersect Illinois team has provided."

GAF, North America's largest roofing and waterproofing manufacturer, will build the company's fifth insulation manufacturing plant in Peru. The project is expected to create 70 jobs and \$80M in investment.



Heinzmann, the German electric mobility company, chose Elk Grove Village for its new manufacturing and office space. The company chose Illinois to be in close to other German companies and will bring an initial 20 jobs and \$1.5M in investment.



Industrial Fence, Inc. is expanding its operations in the North Lawndale neighborhood of Chicago. The veteran-owned company manufactures, fabricates and installs high-quality fencing, guardrail, and related products.



Merkur is a Canadian engineering and professional services firm that located in Downers Grove. The company offers solutions that can help existing and future manufacturers succeed, and it chose Illinois to be surrounded by leaders in advanced manufacturing.



Bright Farms, a leader in producing locally grown packaged salads, expanded its operations to Yorkville by establishing a hydroponic greenhouse farm that delivers to nearby supermarket retailers. The company has an existing farm in Rochelle and plans to create 200 jobs at the new facility.



NewCold, a fast-growing Dutch cold storage company, established its U.S. headquarters in Chicago, supporting the growth of NewCold in North America and bringing 25 jobs.




Tyson expanded its Caseyville prepared foods facility that will increase automation and create 250 new jobs; the \$180 million investment project will help meet growing demand for its iconic Hillshire Farms and Jimmy Dean branded products.



U.S. Medical Glove Co., maker of nitrile glove machines, signed a 15-year lease to repurpose a former Caterpillar factory, creating the largest nitrile machine fabricating and nitrile glove production facility under one roof in the world.



# 04 SUPPORTING GROWTH ACROSS THE STATE

In FY22, Intersect Illinois put increased emphasis on growth in downstate Illinois, including the addition of its first Vice President of Downstate Relations. 


Downstate jobs up 112% and capital investment up 137% over yearly averages.





### Talent, location, community: How Rivian came to be in Illinois

Rivian shook up the automotive world by reimagining the American pickup truck for a new era. To turn its vision into reality, the electric vehicle maker relied on a time-tested formula for success. Namely, it sought to make a home where the crucial ingredients of a welcoming community, skilled talent, and convenient location all come together. Zach Dietmeier, Rivian's Senior Manager of Plant Communications and Policy, told Intersect Illinois about how Normal, IL has become home to the company's tremendous growth.


#### Q. What attracted Rivian to pick Illinois for the site of its first manufacturing facility?

Rivian was initially drawn to the former Mitsubishi factory in Normal by the liquidation sale of equipment from the plant. Upon arrival, the charm, intelligence, and energy of the surrounding community aligned extremely well with our company values. We saw a home for our manufacturing in which we could scale and thrive.

Q. How much has Illinois' central location - and Normal's central location within the state - been a factor in your decision and growth


## 06 | FAM TOURS

Intersect Illinois brought top site selection professionals from Los Angeles, Austin, South Carolina, Chicago and Indiana to tour the Metro East area and Central Illinois, providing insight into the regions' available sites, workforce and unique assets.

The Metro East group attended the Enjoy Illinois 300 NASCAR Cup Series at World Wide Technology Raceway in Madison. They heard from organizations such as Ameren, the Leadership Council of Southwestern Illinois, DCEO, The Freight Way, Boeing, Kaskaskia College, Southwestern Illinois College and more about why Southwestern Illinois is a premier location for businesses.



"The state has made a great turnaround. Illinois is back in the game," said Jim Renzas, Senior Director for North America of BCI Global, who took part in the Metro East FAM tour.



The Central Illinois group explored the region's electric and autonomous vehicle assets, workforce and quality of life. The group attended a baseball game, toured AutonomousStuff, Rivian and Heartland Community College, and met with key economic development partners in the region including Ameren, Norfolk Southern, Wabash Valley Power/Corn Belt Energy, Bloomington-Normal EDC, Greater Peoria EDC, Champaign County EDC, EDC Decatur-Macon County, and Springfield Sangamon Growth Alliance. Presenters

included the University of Illinois Research Park, Rantoul test track and Central Illinois Living Laboratories.

# 07 | SELECTUSA

Intersect Illinois organized a delegation of partners throughout the state to participate in the 2022 SelectUSA Investment Summit, the highest-profile economic summit in the country dedicated to promoting foreign direct investment (FDI) hosted by the U.S. Department of Commerce in Washington D.C.



The annual SelectUSA Investment Summit convened delegations from across the country to promote the United States as the world's premier investment destination. The first in-person SelectUSA Summit since 2019 brought an estimated 3,000 attendees from approximately 80 international markets, offering Illinois and its partners an ideal opportunity to network and create new pathways for investment opportunities.

Team Illinois included representatives from DCEO, Ameren Illinois, Bloomington-Normal EDC, Champaign County EDC, Chicago Southland EDC, ComEd, Greater Peoria EDC, Nicor Gas, Rockford Area EDC, and the Will County Center for Economic Development.


The research team also analyzes projects and industries to determine the best path forward for the business development and marketing teams, as well as developing original research and reports for specific potential projects and community requests.




### **EXPANSIONS AND RELOCATIONS**








## MAP OF EXPANSIONS AND RELOCATIONS

> MAP SHOWS RELOCATIONS/EXPANSIONS FOR **BOTH** FISCAL YEAR 2021 & 2022.






